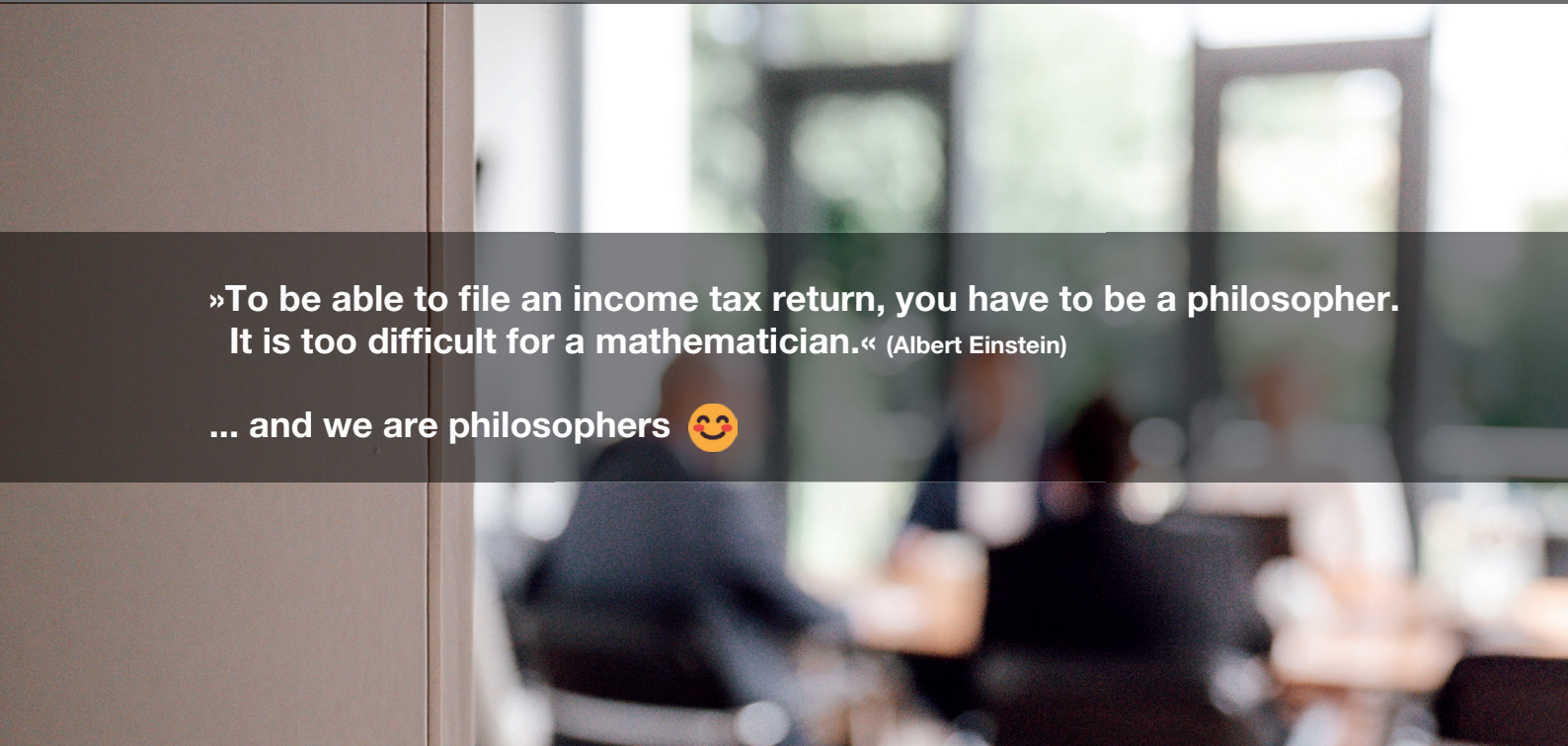

WHEN MOVING TO GERMANY DURING THE YEAR

... everybody with an income in Germany must file an income tax return with the tax authority. If you move to Germany in the current year to work as an employee, you become liable to pay taxes in Germany from the day you enter the country. Income earned in the calendar year prior to the move is not subject to taxation in Germany, BUT is taken into account when calculating the tax rate applied to the income earned in Germany (progression proviso).
